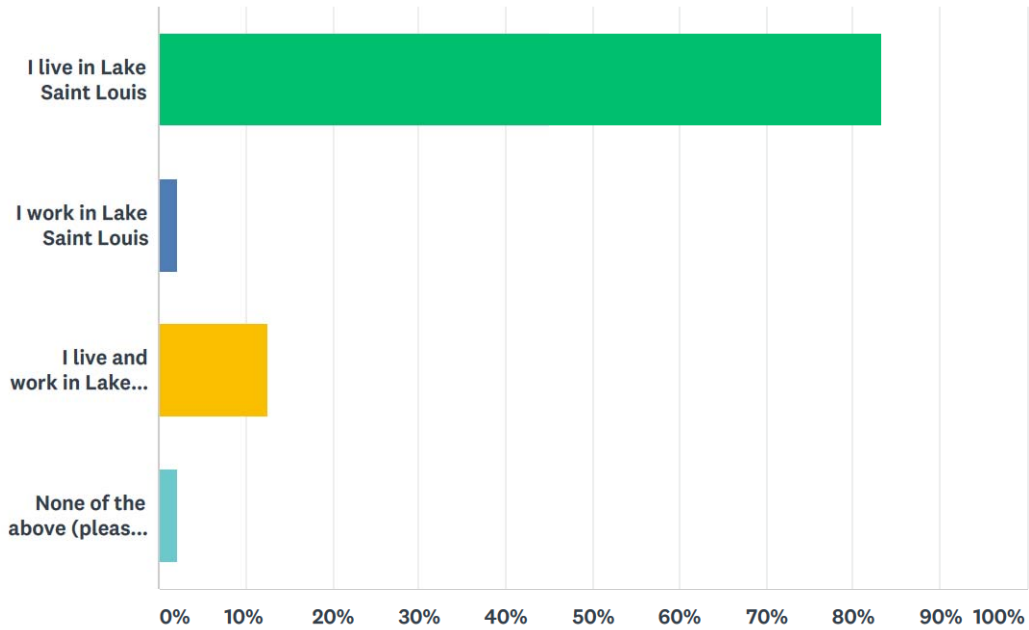

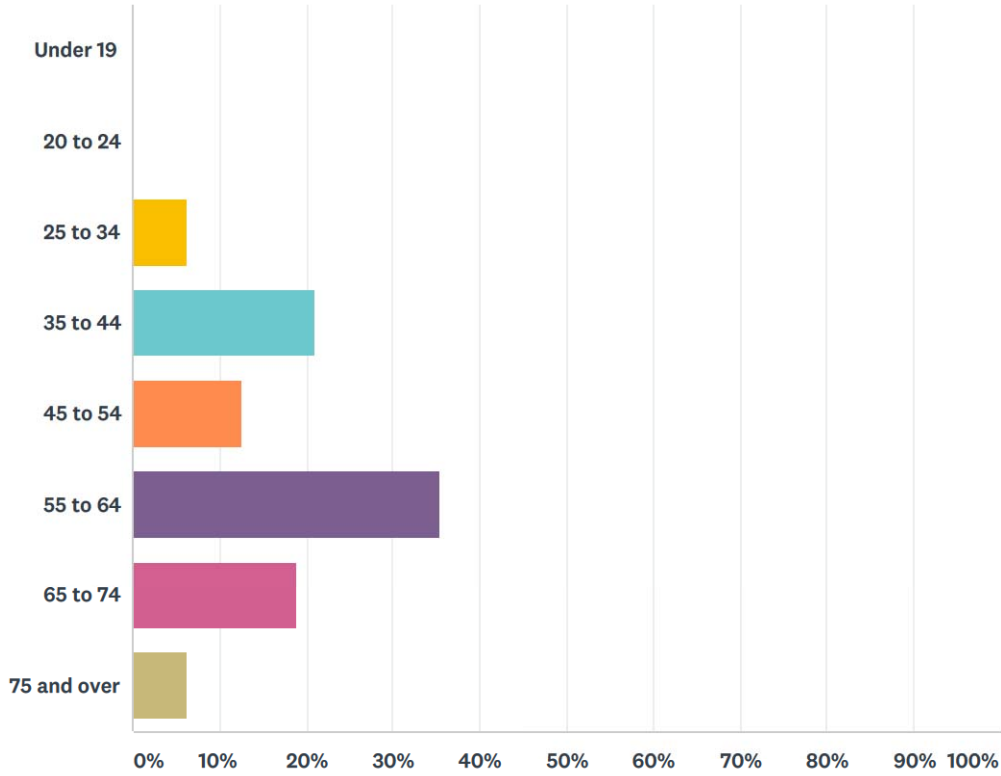

Q3 What is your age?

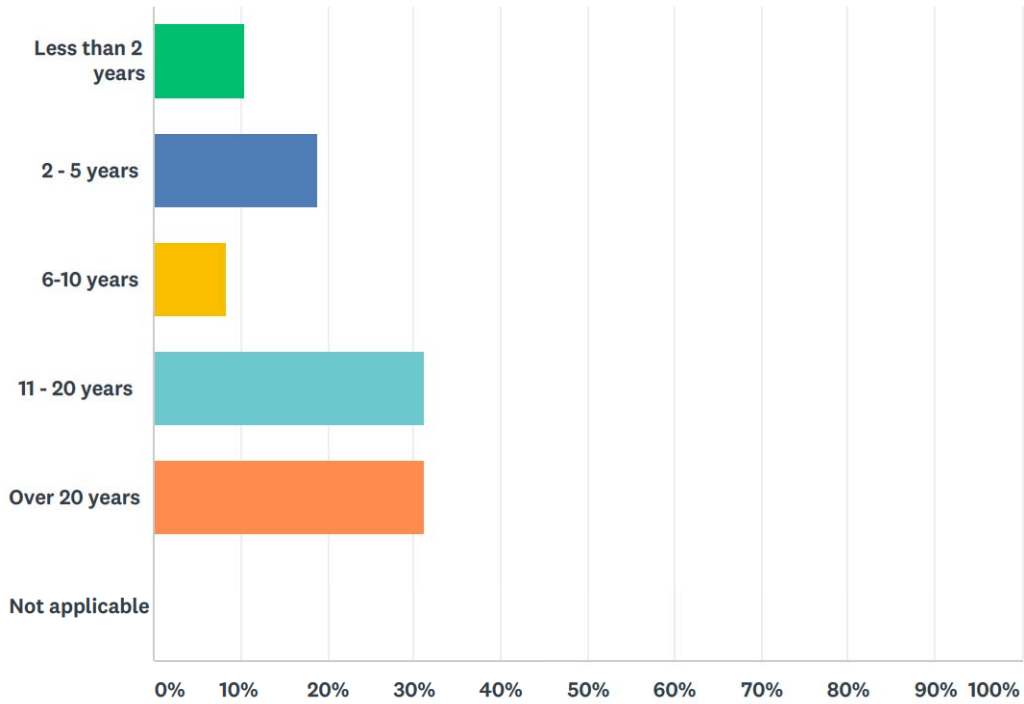

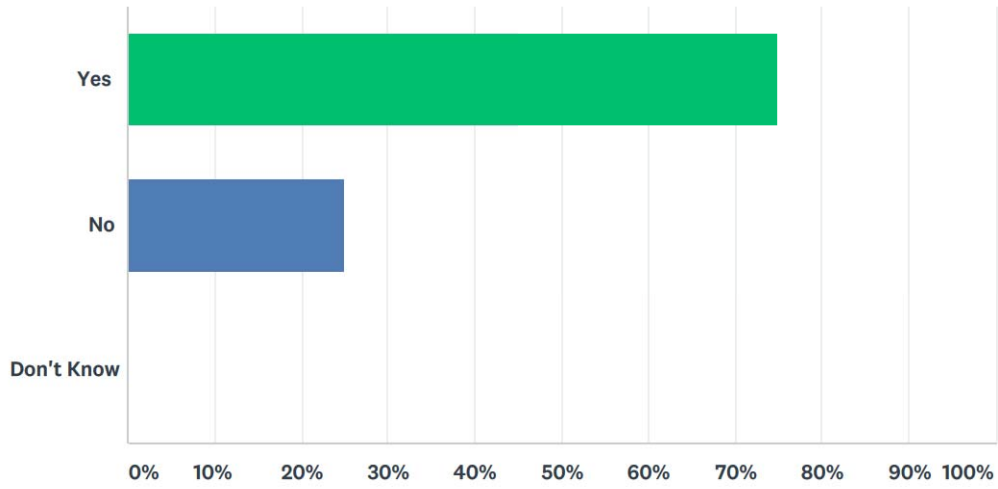

Q5 Are you a member of the Lake Saint Louis Community Association?

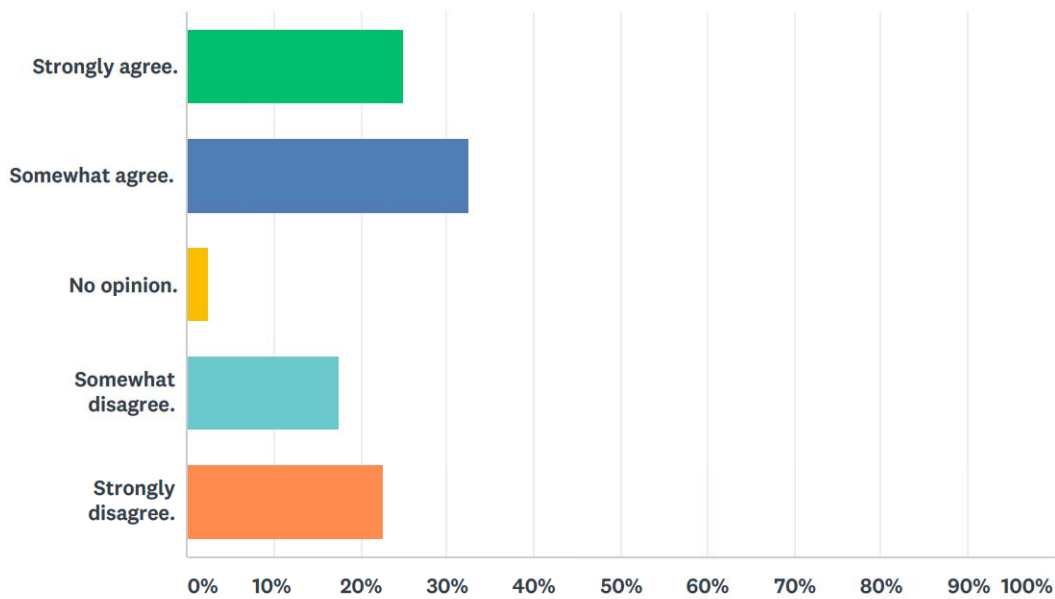

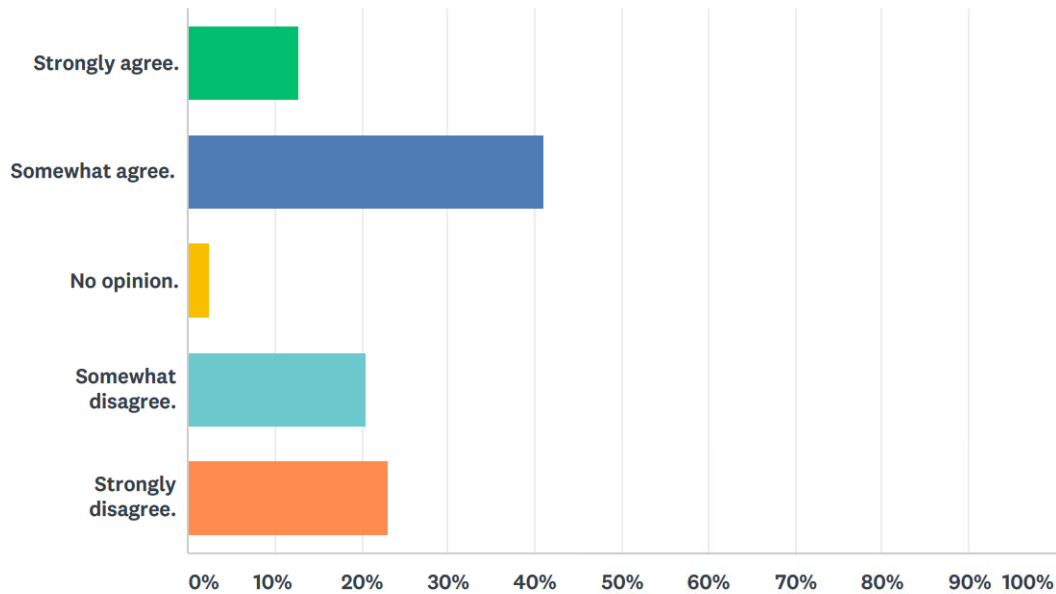
